
# Liver Cancer Awareness Month

## **Liver Cancer Awareness Month**

Hepatitis B and hepatitis C are the <u>leading causes</u> of liver cancer across the world. In the U.S., rising rates of hepatitis C are also causing rising rates of liver cancer. However, only 25% of adults are vaccinated against hepatitis B and about 50% of those living with hepatitis C don't even know it. That's why the <u>CDC</u> <u>has updated their recommendations</u> to urge all adults to get a one-time hepatitis C test, and recommends that people with risk factors, including people who inject drugs, are tested regularly. Once diagnosed, hepatitis C can be cured in <u>as</u> little <u>as</u> 8-12 weeks.

Two NVHR advocates, <u>Bill Remak</u> and <u>Karen Hoyt</u>, have shared their lived experiences with liver cancer as a result of hepatitis C infections. Check out their videos by clicking on the images below!

## **Recent NVHR News**

NVHR and viral hepatitis continue being featured in the news. Check out the latest below!

- NVHR Policy Manager Adrienne Simmons and Treatment Action Group Director of Policy Strategy Annette Gaudino recently <u>spoke with David</u> <u>Lombardo</u>, host of New York Public Radio's *the Capital Pressroom* about hepatitis C in New York. They talked about NY Medicaid's recent removal of prior authorization requirements and more about elimination efforts in the state. <u>Listen to the interview here.</u>
- <u>A recent study</u> by NVHR provider advocate Dr. Lynn Taylor demonstrates the success of co-locating HCV and substance use disorder treatment in a resource-limited setting. Findings show that people who initiated HCV treatment in an urban methadone maintenance program achieved high HCV cure rates.
- NVHR's Adrienne Simmons was also published in <u>Hep Magazine</u> advocating for CMS to delay a proposed Medicaid rule change that could negatively impact hepatitis patients.
- NVHR is hiring a Director! Check out the **job posting and requirements**, and share with those who you think might be interested and qualified.
- NASTAD launched a <u>Hepatitis C Community Navigation Toolkit</u> to help improve care for people who use drugs and other impacted populations. The toolkit can be practically applied to implement and strengthen hepatitis navigation programs.
- The <u>2020 Nobel Prize in Physiology or Medicine</u> was awarded to Harvey J. Alter, Michael Houghton and Charles M. Rice this month for their contributions to the identification of the hepatitis C virus. Their contributions have been critical to developing the cure for hepatitis C and getting us on a path towards elimination.
