Many members of our community serving on the front lines of this response, especially those operating harm reduction programs, have not received resources from any COVID-19 response legislation.

Recent NVHR News

The CDC's Department of Viral Hepatitis released its **2020 Hepatitis Progress Report** and the **2025 Strategic Plan** towards the end of August. The report showed that while some progress has been made towards reducing deaths related to hepatitis B and C, new hepatitis A and hepatitis C cases increased drastically.

The Strategic Plan includes a new focus on **expanding surveillance** to better detect and respond to viral hepatitis outbreaks. The emphasis on surveillance and additional funding for state and local jurisdictions will strengthen the detection of and response to hepatitis outbreaks, but should also include **increased testing and linkage to care** to combat rising hepatitis rates driven largely by increases in injection drug use and the ongoing opioid crisis.

Additional News:

- The <u>Advisory Committee</u> held their inaugural meeting on September 4th.
 During this meeting members learned more about one another and discussed committee charges for the next meeting, including Advisory Committee structure, strategic planning, and membership analysis. The committee will meet on a quarterly basis.
- In case you missed it, the CDC is encouraging PWID to get vaccinated for hepatitis A and B amid hepatitis A outbreaks and rising rates of viral hepatitis due to injection drug use. Check out new resources and more information here.



Hepatitis Virtual Collaborative

NASTAD and The AIDS Institute are excited to host the first ever Hepatitis Virtual Collaborative! It is a partial-day opportunity for hepatitis and infectious disease advocates and patients from across the country to come together virtually to connect with each other and learn about what jurisdictions are doing to combat viral hepatitis in their communities through presentations and conversations. Best of all, it's FREE!

Presentations will include hepatitis elimination strategies and how a syndemic approach must be taken that incorporates responses to the viral hepatitis epidemics, overdose prevention, and other public health efforts. Additional barriers to advancing hepatitis elimination will also be examined, including criminalization of hepatitis and drug use, discrimination and stigma concerns, treatment access issues in correctional settings, vaccination barriers, and health inequities.
