

NASTAD in partnership with National Viral Hepatitis Roundtable (NVHR) and National Association of County and City Health Officials (NACCHO) are implementing and facilitating the Hepatitis Network for Education and Testing (HepNET). In collaboration, we will work with state and local health departments (LHDs), community-based organizations (CBOs), clinical providers, people with lived experience, syringe services programs (SSPs) and harm reduction programs, and other key partners to identify and address the unmet needs of people who inject drugs (PWID) and improve their access to viral hepatitis education, prevention, testing, linkage to care, and treatment.

POLICY UPDATES

CDC Formally Adopts Universal Hepatitis B Vaccination For All Adults Ages 19-59. The adoption of this recommendation, which shifts CDC guidance from risk-based guidelines to a universal recommendation, moves the United States closer to our goal of eliminating viral hepatitis by stemming the tide in hepatitis B infections across the country, particularly for communities who have long been subjected to health inequities. President Biden Submits FY23 Budget Proposal, Calling for Historic Increase for CDC Division of Viral Hepatitis Budget. President Biden's FY 23 budget proposal includes a \$13.5 million increase for the CDC Division of Viral Hepatitis, a historic increase in year-over-year funding by percentage. In addition, the budget request calls for a new Vaccines for Adults (VFA) program and references harm reduction as a core element of the Biden-Harris Administration's drug strategy. Although the increased funding will help improve viral hepatitis testing and increase linkage to care, there remains a significant amount of work to be done to fully eliminate viral hepatitis in the United States .Read NVHR's full **statement**.

Adult Hepatitis B Vaccination Awareness Day is April 30. With the recent finalizing of universal hepatitis B vaccination recommendations for adults aged 19-59, opportunities and challenges remain in scaling up HBV vaccination. National Hepatitis Testing Day is May 19. The goal of Hepatitis Testing Day is to help raise awareness of hepatitis B and hepatitis C and to encourage more individuals to learn their status. It is a day for people at risk for viral hepatitis to be tested, and for health care providers to educate patients about viral hepatitis and testing. NVHR is excited to announce the hiring of **Kass Botts** as its new Coalition and Capacity Building Manager. In their role, Kass will lead the HepNET partnership with NASTAD and NACCHO, among other partnership projects.

Kass Botts is a drug user human rights activist living in Bloomington, Indiana, with a background in the Harm Reduction movement and community-based organizational leadership. They began their work in viral hepatitis elimination as the Executive Director of the Indiana Recovery Alliance, a drug user led Harm Reduction services organization. They are a member of the Region 9 Leadership Team for the Zero is Possible (ZIP) Coalition, a statewide initiative bringing together the essential people, tools, and resources to end the HIV epidemic and eliminate Hepatitis C (HCV) in Indiana. In 2021 they founded the Hoosier Harm Reduction Coalition, a statewide network of people who use drugs and other harm reduction stakeholders across the state of Indiana. Kass currently serves as the Board President of the Tennessee Recovery Alliance, another harm reduction services organization based in Knoxville, Tennessee. Kass has professional experience in marketing and communications, community based participatory action research, rural community engagement, and policy and advocacy. They are most passionate about community organizing, restorative and

transformative justice, and their work with the National Urban Survivor's Union toward drug user liberation.

CDC: Federal Register Notice Soliciting Comments on Proposed Hep B Screening Recommendations

On April 4, 2022, the Centers for Disease Control and Prevention (CDC) published a Federal Register Notice (FRN) #CDC-2022-07050 to obtain comment on proposed hepatitis B screening and testing recommendations. The recommendations supplement CDC's 2008 screening recommendations by including hepatitis B screening at least once in a lifetime for adults aged 18 years and older, using a three-test panel. Screening with three tests can help identify persons who have a current HBV infection, have resolved infection and who may be susceptible to reactivation, are susceptible and need vaccination, or are vaccinated.

The Federal Register Notice will be open for public comment for 60 days and closes on <u>June 3</u>, <u>2022</u>. To review, please click below and enter "CDC-2022-0044" in the search bar.

CDC will host a webinar on <u>April 20, 2022, at 2pm ET</u> to present an overview of the <u>proposed recommendations</u>. <u>Registration</u> is required.
